- 1. Funding

- 2. 10-year plan
  - a. Global Water loggers will be replaced with ENO Well Watch 670 as the existing loggers retire from service. The BNT website will have to be upgraded to accept an external Wi-Fi streaming signal for "live" data streaming. M. Lennon has agreed to continue technical support for data collection.
- 3. New laptop
